Proposals for Draft Amendments to the Constitution of the European Scout Region

European Scout Committee

The European Scout Committee proposes that the 24th European Scout Conference (2022) adopt the following Draft Amendments to the Constitution of the European Scout Region of the World Organization of the Scout Movement.

A brief explanation, the text of the Draft Resolution and background information are included in the Conference Document to provide Member Organisations with the required information to facilitate discussions before a decision is made by the Conference during a voting session at the Conference.

Draft Amendments to the Constitution of the European Scout Region

Background

The Constitution of the European Scout Region consists of the set of fundamental principles and rules according to which the European Scout Region is acknowledged to be governed. As per international good governance best practices it should be regularly considered for review to reflect the most recent changes and current practices of the organisation.

In light of this best practice, the European Scout Committee has considered the need to review the Constitution of the European Scout Region and agreed to proceed with the following proposal.

It is of note that the Constitution of the European Scout Region was reviewed in 2019. The proposed amendments to the 2016 version can be found under the following links:

It is worth noting that all Draft Amendments to the Constitution of the European Scout Region proposed in this document were submitted for review to the Constitutions Committee of the World Scout Committee to ensure compliance and alignment with the Constitution of the World Organization of the Scout Movement (WOSM Constitution).

Draft Amendments (wording)

The proposed changes **in green** are language-based to bring:

- **Consistency:** To avoid misinterpretations, short references (such as "Constitution" or "Region" or "Committee") are eliminated and replaced by the full name of the reference. Short references are only kept in case they clearly refer to the very constitution of the European Scout Region. Furthermore, some expressions were changed in order to be consistent with the current practice ("Regional Director" instead of "Secretary") or with the WOSM Constitution ("Member Organizations" instead of "National Scout Organizations"). Proposals for such changes appear in the preamble as well as in Articles I, II, IV, V, VI, and VII.
- **Updated terminology:** The adjective "kindred" appearing in the preamble as well as in Article II was considered as an outdated expression which does not necessarily add value to express the spirit of Scouting. Therefore, the proposal is to remove the word.

Draft Amendments (content)

The proposed changes **in blue** are content-based:

Purpose and principles (Article II)

With the latest and substantial development of the European Scout Region, the opportunity to reflect the latest evolution in our purpose and principles was considered. The following elements have been identified as defining principles of the European Scout Region: Youth Involvement, Diversity and Inclusion, and Safe from Harm.

1. **Youth Involvement:** While reference is made in Article II "Purpose and Principles " the European Scout Committee encourages explicit reference when describing our purpose and principles. Such reference is also very common in the Constitutions of Member Organisations.
2. **Diversity and Inclusion:** Over the past four Triennia, Diversity and Inclusion were present as a strategic priority, an important area of work and more recently a WOSM Service. In practice, the focus on diversity and inclusion has continued to evolve reaching all aspects of our activities and operations. The European Scout Committee believes it is fundamental to consider diversity and inclusion in all areas of work of the European Scout Region and supports its integration as a principle.

3. Safe from Harm: With the adoption of the World Scout Conference Resolution 2021-D and the amendment to the WOSM Constitution (new Article V.5.e), the European Scout Committee, in consultation with the Constitutions Committee, supports reiterating this requirement on a WOSM level as a principle at Regional level.

The role of the European Scout Committee (Article IV)

Building on the evolution of the role of the European Scout Committee as the governance body of the organisation, as well as on the expectations for a Committee which serves, guides and steers the European Scout Region, the European Scout Committee sees an opportunity to further define its governance role on a strategic level. The proposed addition also aims at supporting a clear link and understanding of its responsibilities (which are further defined in its own governance resources). To further emphasise the strategic role of the European Scout Committee, further input was added to its ability to establish subsidiary structures.

The role of the European Regional Office (Article V)

Following the same approach, changes were made to this article building on the operational functions of the European Regional Office. While the current version of the Constitution refers to the European Regional Office as a secretariat – which is indeed an important function of the office - the term secretariat limits the function of the European Regional Office to administrative support to the European Scout Region. This does not reflect the important role staff has in the implementation of the Regional Scout Plan and respective activities. Elements were added to the description of the function of the European Regional Office to reflect the current practice. The wording used also reflects language used in the WOSM Constitution.

Proposed Draft Amendments to the Constitution of the European Scout Region

The 24th European Scout Conference,

- *Conscious* that the Constitution of the European Scout Region consists of the set of fundamental principles and rules according to which the European Scout Region is acknowledged to be governed, and
- Recognising that, as per international good governance best practices, it should be regularly considered for review to reflect the most recent changes and current practices of the organisation.

Adopts the following proposed draft amendments to the Constitution of the European Scout Region of the World Organization of the Scout Movement:

- c) An extraordinary meeting may be called on the decision of the European **Scout** Committee, or at the request of not less than one third of the Member Organizations.

3. Quorum

- a) Delegations from not less than half of the recognised Member Organizations in Europe shall constitute a quorum for any meeting of the Conference.

4. Voting

- a) Each Member Organization shall have six votes and resolutions shall be taken by a simple majority of members present or represented and voting. In the event of a tie, the motion is defeated.

- On election, and following discussion with fellow committee members, all elected members must declare any possible conflicts of interest arising from positions held in their own or other Scout associations, which would lead to permanent conflicts of interest concerning their perceived impartiality. Positions on the national board and that of International Commissioner, would automatically be conflicts of interest, and such positions would require to be resigned within four months of election.
- A conflict-of-interest register will be established so that members may declare, at any time, issues and interests they may have institutionally and personally that impact on their contribution to decision making or influence by the Committee.

3. Organisation of the Committee

a) The European Committee shall elect its own Chairperson and Vice-Chairperson. The Chairperson or the Vice-Chairperson, on election, becomes an ex-officio non-voting member of the World Scout Committee. The European Committee may appoint any one of its members for a special task; it may invite any person whom it may deem useful in accomplishing its task as a consultant without vote.

b) The European Committee shall elect an external specialist to serve as Treasurer. The Treasurer will attend meetings of the European Committee as ex-officio non-voting member of the Committee. The Treasurer is formally appointed by the Treasurer of the World Scout Committee for a three-year period after consultation with the European Scout Committee. Positions on the national board and that of International Commissioner, would automatically be conflicts of interest, and such positions would require to be resigned within four months of election.
- A conflict-of-interest register will be established so that members may declare, at any time, issues and interests they may have institutionally and personally that impact on their contribution to decision making or influence by the **European Scout** Committee.

3. Organisation of the Committee

a) The European **Scout** Committee shall elect its own Chairperson and Vice-Chairperson. The Chairperson or the Vice-Chairperson, on election, becomes an ex-officio non-voting member of the World Scout Committee. The European **Scout** Committee may appoint any one of its members for a special task; it may invite any person whom it may deem useful in accomplishing its task as a consultant without vote.

b) The European **Scout** Committee shall elect an external specialist to serve as Treasurer. The Treasurer will attend meetings of the European Committee as ex-officio non-voting member of the Committee. The Treasurer is formally appointed by the Treasurer of the World Scout Committee for a three-year period after consultation with the European Scout Committee.
