**17TH EUROPEAN
GUIDE AND SCOUT CONFERENCE
ROTTERDAM, THE NETHERLANDS
22-27 JULY 2022**

Introduction

This document records all decisions made at the 17th European Guide and Scout Conference and serves as Conference Report. All conference documents are available on the website of the Conference:

The 17th European Guide and Scout Conference was hosted by Scouting Nederland and was held at De Doelen Conference Centre in Rotterdam, the Netherlands. The Conference met on 23 and 26 July 2022 for a total of two half day sessions.

Conference Opening

The chairpersons of the two Regional Committees, Eline Grøholt (Europe Committee WAGGGS) and Lars Kramm (European Scout Committee, WOSM) officially declared open the 17th European Guide and Scout Conference on 23 July 2022, when they welcomed delegates, observers, and guests from across Europe and even further afield.

The programme of the Conference included the following main elements:

- Meet the Candidates for election to the European Committee WAGGGS and the European Scout Committee

- Rotterdam Evening

- Closing Session of the 17th European Guide and Scout Conference EGSC

Roll Call

450 people from 37 National Scout Organisations (NSOs) of WOSM and 32 Member Organisations (MOs) of WAGGGS from 42 countries in the two European Regions were present at the beginning of the Conference. It was announced that all delegations were in compliance with provisions of the Conference's proposed Joint Rules of Procedure and therefore had the right to vote in conformity with art 2.2 and 2.3 of the Joint Rules of Procedure proposed for the 17th European Guide and Scout Conference ([Joint Conference Document 1b](#)). At the moment of the Roll Call 39 delegations were present in plenary, representing a total of 69 votes. Simple majority was therefore 34 votes.

Joint Rules of Procedure

The initial draft version of the Joint Rules of Procedure was endorsed by the Joint Meeting of the Europe Committee WAGGGS and the European Scout Committee on March 2022. In absence of any draft amendments proposed by Member Organisations, the final draft version circulated in May 2022 ([Joint Conference Document 1b](#)) did not include any changes compared with the previous version.

Noting that no proposals for additional agenda item or for amendments of the circulated Draft Agenda for the 17th European Guide and Scout Conference had been received, the European Scout Committee and the Europe Committee WAGGGS proposed to follow the Agenda as circulated.

Presentation of Roverway 2024

The Planning Team from Speidernes Fellesorganisasjon (NO), host organisation of Roverway 2024, presented an overview of the status of planning of this major event in the European regions from Scouts and Guides between 18 and 25 years of age. The event will take place “North of the Ordinary” in Northern Norway in Summer 2024.

Presentation of the Bids to Host the 18th European Guide and Scout Conference in 2025

Representatives from Pfadfinder und Pfadfinderinnen Österreichs (AT) presented their bid to host the 18th European Guide and Scout Conference. This was the only bid the European Regions had received from Member Organisations to host the next Regional Conference.

Report on Joint Work 2019-2022

Eline Grøholt and Martin Seeman, Chairperson of the Europe Committee WAGGGS and Vice Chairperson of the European Scout Committee, respectively, presented the Report on Joint Work undertaken during the outgoing Triennium.

During the Triennium 2019-2022, the Joint Committee met in person twice and on numerous occasions online. The in-person meetings took place in Duisburg, Germany, in March 2020, and in Rotterdam, the Netherlands, in March 2022.

A number of the key achievements of Joint Work were reported to the Conference:

Refugees and Human Rights Joint working group

- Webinar on Refugees
- Ideathon on Refugees and Human Rights (Paris, 2022)
- Workshops at the Academies in 2019, 2020 and 2021

Azimuth - the tool to facilitate international Guiding and Scouting experiences

- Connect across Europe- Thanks to Azimuth, you can easily get in touch with Scouts and Guides to create international projects.
- Explore new places- New adventures are just a click away. Start them now!
- Easy to use system- Azimuth isn't the bottleneck of new explorations.

The Academy

- The flagship training event of and for both Regions. Held in Slovenia in 2019 and online in 2020 and 2021
- More than 100 participants, including at the two online versions
- The Academy 2021 was held spread over two weeks with webinars during the weekends and self-followed sessions during the weekdays.

IC Forum 2022

- Held online on Gathertown in February 2022
- Workshops & networking for International Commissioners (ICs) from both Regions
- Some topics from the workshops: Sending participants to International Events, Managing International Teams, Youth Delegates Programme, Implementing World Policies, Initiatives, and Programmes at National Level

Final Conclusions

A big “thank you” was expressed to the volunteers and staff who delivered the Joint Work during the outgoing Triennium. A strategic review of Joint Work was initiated during the Triennium but did not fully materialise. With the updated Memorandum of Understanding and a Joint Action Plan for the Triennium 2022-2025 the two Regions aim at bringing more clarity to Joint Work. The two Regional Committees are dedicated to continuing developing Joint Work in line with the Memorandum of Understanding and Joint Action Plan.

Vote to determine the host of the 18th European Guide and Scout Conference

Following the presentation of the bid by the only candidate earlier during the Conference, the 17th European Guide and Scout Conference voted to accept the bid from Pfadfinder und Pfadfinderinnen Österreichs (Austria).

The bid was accepted with 64 votes in favour, 3 against, and 1 abstention. The 18th European Guide and Scout Conference will therefore take place in Vienna, Austria, in the summer of 2025.

Report of the Recommendations Committee

The Recommendations Committee acknowledged the submission and receipt of two draft recommendations from the Joint Committee - 17EGSC-JC01 & 17EGSC-JC02, as well as one bid to host the 18th European Guide and Scout Conference in 2025.

The Recommendations Committee reported that no draft amendments to the two proposed draft recommendations had been submitted. Therefore, the Committee put forward for debate and voting the two draft recommendations as submitted by the Joint Committee (for their text, please refer to [Joint Conference Document 3](#)).
